

**ORDINANCE NO. 2007-01**

AN ORDINANCE OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA; ADOPTING CERTAIN PROVISIONS OF ORDINANCE NO. 06-55 OF BREVARD COUNTY; PROVIDING FOR CERTAIN MODIFICATIONS TO ORDINANCE NO. 06-55 OF BREVARD COUNTY; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

**WITNESSETH:**

**WHEREAS**, Brevard County adopted Ordinance No. 06-55 relating to landscaping, land clearing and tree protection and filed it with the Secretary of State on November 1, 2006; and

**WHEREAS**, the Town Council finds that adoption of the County Ordinance is in the best interest of the citizens of the Town of Grant-Valkaria; and

**WHEREAS**, the Town Council in providing for the health, safety and welfare of its citizens, has determined that is necessary to adopt, as its own certain provisions of Ordinance No. 06-55.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA, AS FOLLOWS:**

Section 1. The Town Council for the Town of Grant-Valkaria hereby ratifies, confirms, adopts sections 3 through 17 of Ordinance No. 06-55 of Brevard County, as applicable to the Town of Grant-Valkaria, subject to the modifications herein..

Section 2. Any reference to Brevard County or County in Ordinance No. 06-55 are hereby replaced with the words Town of Grant-Valkaria or Town as the context requires. Any reference to County Commission or Commission in Ordinance No. 06-55 is replaced with the words Town Council or Council as the context requires. All references to Division in Ordinance No. 06-55 are replaced with the word Ordinance.

Section 3. Any reference to other provisions of Brevard County Code, Brevard County Comprehensive Plan, Chapter or Article shall remain until the Town adopts its own Code and/or Comprehensive Plan.

Section 4. The Town shall establish its own schedule of fines in accordance with Section 8 of Ordinance 06-55 of Brevard County.

Section 5. Severability.

In the event a court of competent jurisdiction shall hold or determine any or part of this ordinance invalid or unconstitutional, the remainder of this ordinance shall not be affected.

Section 6. Effective Date.

This ordinance shall take effect thirty days after its adoption.
