

RESOLUTION NO. 16-2008

A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA; TO OFFICIALLY RENAME SHARK BAIT LANE (FORMERLY ANGELTROUT LANE) TO PASSION FISH LANE, LOCATED WITHIN THE TOWN OF GRANT-VALKARIA, REQUESTING THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA TO PLACE THE NAMED PRIVATE ACCESS ON THE OFFICIAL MAPS OF RECORD; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Grant-Valkaria, Brevard County, Florida has been requested to rename the following private access previously named Shark Bait Lane by unrecorded Resolution 13-2008 and Angeltrout Lane by Resolution 2002-A084 recorded in ORB 4716/0770-0771 – Tax Account #3010480 (T30-R38-S03-00-779):

A private access located in Section 03, Township 30 South, Range 38 East, Brevard County, Florida, being more particularly described as follows: Commence at the intersection of the north right-of-way line of Ambersand Place and the west right-of-way line of U.S. Highway 1; thence run north along said west right-of-way line approx. 1190 feet to the Point of Beginning; thence run west approx. 330 feet; thence run north approx. 25 feet; thence run east approx. 320 feet to the west right-of-way line of U.S. Highway 1; thence run south along said right-of-way line approx. 25 feet to the Point of Beginning; as indicated on attached map, marked “Exhibit A”, and:

WHEREAS, the above-described private access should be named to improve location identification for 9-1-1 purposes and has been approved by the Brevard County E9-1-1 Administration as per interlocal agreement; and,

WHEREAS, Resolution No. 13-2008 renamed Angeltrout Lane to Shark Bait Lane and before the document was recorded and distributed to concerned agencies, the owner resubmitted another name choice being Passion Fish Lane; and,

WHEREAS, the Town of Grant-Valkaria, Brevard County, Florida requests the Board of County Commissioners of Brevard County, Florida to place the above-named private access on the official maps of record; and,

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Grant-Valkaria, Brevard County, Florida that:

1. The name **PASSION FISH LANE** be adopted for the above-described private access.
2. Addresses shall be assigned accordingly off the above-named access.
3. By naming this private access, the Town of Grant-Valkaria in no way accepts maintenance responsibilities for said access.
4. It shall be the property owner’s responsibility to place the appropriate street sign(s) and keep said private access clear and accessible for emergency vehicles.

5. This naming shall become effective upon adoption of this resolution.
6. The Resolution be recorded in the Official Records Book in the office of the Clerk of the Circuit and County Courts, and a copy of same be forwarded to the Post Office serving that area, Supervisor of Elections, and all concerned public safety agencies for their information, and that the proper notations be made on all maps of record.
