

RESOLUTION NO. 02-2009

A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA; TO OFFICIALLY NAME MEDJOOL ROAD, LOCATED WITHIN THE TOWN OF GRANT-VALKARIA, REQUESTING THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA TO PLACE THE NAMED ROAD RIGHT-OF-WAY ON THE OFFICIAL MAPS OF RECORD; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Town of Grant-Valkaria, Brevard County, Florida has been requested to name the following:

A road right-of-way located in Section 35, Township 29 South, Range 37 East, Brevard County, Florida, being more particularly described as follows: Commence at the northwest corner of the northeast  $\frac{1}{4}$  in said Section 35; thence run south approx. 50' to a point on the south right-of-way line of Grant Road; thence run east approx. 25' to a point on the northwest corner of Parcel 32, said point also being the Point-of-Beginning; thence run south approx. 1,550' to a point; thence run west approx. 50' to a point on the east line of Parcel 263; thence run north approx. 1,550' to a point on the south right-of-way line of Grant Road; thence run east approx. 50' to the Point of Beginning; as indicated on the attached map, marked "Exhibit A," and:

**WHEREAS**, the above-described road right-of-way should be named to improve location identification for 9-1-1 purposes and has been approved by the Brevard County E9-1-1 Administration as per interlocal agreement; and,

**WHEREAS**, the Town of Grant-Valkaria, Brevard County, Florida requests the Board of County Commissioners of Brevard County, Florida to place the above-named road right-of-way on the official maps of record; and,

**NOW, THEREFORE**, BE IT RESOLVED by the Town Council of the Town of Grant-Valkaria, Brevard County, Florida that:

1. The name **MEDJOOL ROAD** be adopted for the above-described road right-of-way.
2. Addresses shall be assigned accordingly off the above-named road right-of-way.
3. The Town of Grant-Valkaria will accept maintenance responsibility upon full compliance with the unpaved road agreement.
4. It shall be the property owner's responsibility keep said road right-of-way clear and accessible for emergency vehicles.
5. This naming shall become effective upon adoption of this resolution.
6. The Resolution be recorded in the Official Records Book in the office of the Clerk of the Circuit and County Courts, and a copy of same be forwarded to the Post Office serving

that area, Supervisor of Elections, and all concerned public safety agencies for their information, and that the proper notations be made on all maps of record.
