

**RESOLUTION No. 04-2009**

**A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY; APPROVING AN APPLICATION FOR A SPECIAL EVENT PERMIT FOR “AIR FEST” AT 2865 GREENBROOKE STREET SUBMITTED BY VALKARIA AVIATION ASSOCIATION INC; IMPOSING CONDITIONS; PROVIDING FOR SEVERABILITY, REPEAL AND AN EFFECTIVE DATE.**

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GRANT-VALKARIA, FLORIDA:**

**SECTION 1:** The Town Council hereby approves the application by the Valkaria Aviation Association Inc (VAA) for a special event permit for a general aviation air show with static displays, aerial displays, aerobatics, food and dry good vendors, aircraft rides, children’s activities, and educational and historical presentations at 2865 Greenbrooke Street subject to the following conditions:

- (1) The applicant shall comply with all applicable requirements of Chapter 10, Amusements and Entertainments, Brevard County Code of Ordinances, and shall be strictly limited to the following:
  - a. Anticipated crowd total to be 4,000;
  - b. Rain date allowed as February 22, 2009;
  - c. 6 + tents - 10’ x 10’; 20’ x 20’; canopies allowed provided flame resistant certificate is in file;
  - d. Outside music allowed for small 3 or 4 piece musical band and DJ with CDs, with sound system approximately 86 DCBs;
  - e. Ramp Static displays;
  - f. Model Aircraft Flying Demonstrations;
  - g. Wavered Airspace Aerial demonstrations;
  - h. Twilight aerial demonstration;
  - i. Parachute jumping;
  - j. Non-aerobatic fly bys;
  - k. Aerobatics;
  - l. Food, dry good vendors, and sponsors (no alcoholic beverage sale or consumption);
  - m. Aircraft and helicopter rides;
  - n. Car and motorcycle rally;
  - o. Children’s play area;
  - p. Education and historical presentations;

- q. Signs with dimensions of maximum 4' x 4' and minimum 18" x 24"; height 4' and 18";
  - r. Approximately 24 portable toilets and 2 handicapped portable toilets;
  - s. Performing aircraft;
  - t. Operations and security office;
  - u. Fueling area;
  - v. V.I. P. and general admission seating;
  - w. Air fest, safety volunteer and security tent;
  - x. Tethered balloon;
  - y. Civil Air Patrol area;
  - z. Flight's for hire that include Fly High Wisconsin, LLC, Kissimmee, FL, John Lumley, Delray Beach, FL, and Cabanas Aerobatics, In; Fred Cabanas and M & F Flying dba #3 Parrott Street, Key West, FL.
- (2) In addition, a permit may be immediately suspended or revoked by the Town Administrator, Mayor or his designee if:
- a. It is determined at any time the applicant has made a material misrepresentation on the application;
  - b. Any activity conducted in conjunction with the special activity permit has created or caused a safety hazard;
  - c. The applicant violates any law, ordinance or regulation of the state of Florida, Brevard County or the Town in the conduct of the special activity.
  - e. Violates any of the items conditions on as in Section 1(1).
- (3) The applicant has been granted an exemption from the sign permit.
- (4) The applicant shall be responsible for all damage and repairs to any portion of the Valkaria Road right-of-way for which driveway permit number 08-LCL-00012 has been issued.
- (5) The special event permit shall be a one day permit for Saturday, February 21, 2009 from 8:00 a.m. to 6:30 p.m. or in the event of rain, this permit shall be permitted for Sunday, February 22, 2009 from 8:00 a.m. to 6:30 p.m.

SECTION 2: All resolutions or parts of resolutions in conflict herein are repealed.

SECTION 3: Effective Date.

This resolution shall become effective immediately upon its adoption and shall expire at 6:31 p.m. on February 21, 2009, or in the event of rain, shall expire at 6:31 p.m. on February 22, 2009.
