**RESOLUTION NO. 02-2011**

**A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY; APPROVING AN APPLICATION FOR A SPECIAL EVENT PERMIT FOR “AIR FEST” AT 2865 GREENBROOKE STREET SUBMITTED BY VALKARIA AVIATION ASSOCIATION INC ADDRESSING PARKING AND TRAFFIC SAFETY ISSUES ONLY; IMPOSING CONDITIONS; PROVIDING FOR SEVERABILITY, REPEAL AND AN EFFECTIVE DATE.**

**NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GRANT-VALKARIA, FLORIDA:**

**SECTION 1:** The Town Council hereby approves the application by the Valkaria Aviation Association Inc (VAA) for a special event permit for a general aviation air show at 2865 Greenbrooke Street subject to the following conditions:

- (1) The applicant shall comply with all applicable requirements of Chapter 10, Amusements and Entertainments, Brevard County Code of Ordinances, and shall be strictly limited to the following:
  - a. Anticipated crowd total to be 5,000;
  - b. Rain date allowed as February 20, 2011;
  - c. 6 Signs with maximum dimension of 4’ x 8’ each and an additional signage at the Airport entrance sign;
  - d. Copy of agreement with Brevard County Sheriff’s Office to provide extra patrol services;
  - e. Security lights shall be installed at the intersection of Fairgreen Street and Valkaria Road which shall be on at least one hour before sunset and until the event is over.
  - f. Sheriff’s Deputy shall be present between the hours of 8:00 a.m. until 7:00 p.m., and may designate a member of the Citizen on Patrol (COPs) program, to perform traffic control at the intersection described in subsection “e” above.
  
- (2) In addition, a permit may be immediately suspended or revoked by the Town Administrator, Mayor or his designee if:
  - a. It is determined at any time the applicant has made a material misrepresentation on the application;
  
  - b. Any activity conducted in conjunction with the special activity permit has created or caused a safety hazard;

- c. The applicant has violated any law, ordinance or regulation of the state of Florida, Brevard County or the Town in the conduct of the special activity.
  - d. Violates any of the conditions in Section 1(1).
  - e. The applicant has failed to supply the Town an insurance certificate naming the Town as an additional insured on the applicant's general liability policy.
- (3) The applicant has been granted an exemption from the sign permit.
- (4) The special event permit shall be a one day permit for Saturday, February 19, 2011 from 7:00 a.m. to 9:00 p.m. or in the event of rain, this permit shall be permitted for Sunday, February 20, 2011 from 7:00 a.m. to 9:00 p.m.
- (5) The applicant is hereby granted special permission to install No Parking signs on the Town right-of-way known as Valkaria Road adjacent to the airport property and is authorized to request any person who is deemed in violation of the No Parking prohibition to immediately vacate the said area.
- (6) The applicant has agreed to provide a representative from the FAA and an Air Boss at the event during all aeronautics exercises.
- (7) The applicant shall provide the Town with a copy of the Brevard County special event permit
- (8) All documents shall be submitted to the Town no later than 6:30 p.m., Wednesday, February 16, 2011.

**SECTION 2:** All resolutions or parts of resolutions in conflict herein are repealed.

**SECTION 3:** Effective Date. This resolution shall become effective immediately upon its adoption and shall expire at 9:01 p.m. on February 19, 2011, or in the event of rain, shall expire at 9:01 p.m. on February 20, 2011.
