A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA; AMENDING BUDGET RESOLUTION NO. 19-2010 BUDGET RESOLUTION FOR FISCAL YEAR, OCTOBER 1, 2010 THROUGH SEPTEMBER 30, 2011 BY REALLOCATING CERTAIN AMOUNTS SHOWN BY LINE ITEM TRANSFERS; THERE IS NO CHANGE IN TOTAL ANTICIPATED REVENUES; THERE IS NO CHANGE IN TOTAL ANTICIPATED EXPENDITURES; PROVIDING AN EFFECTIVE DATE.
