

RESOLUTION 01-2006

A RESOLUTION OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA, ADOPTING A MUTUAL AID AGREEMENT WITH THE STATE; PROVIDING FOR REPEAL OF RESOLUTIONS OR PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Grant-Valkaria, like other communities in the State of Florida, is vulnerable to a wide range of disasters that are likely to cause disruption of essential services and the destruction of infrastructure needed to deliver those services; and,

WHEREAS, such disasters are likely to exceed the capability of the Town of Grant-Valkaria to manage the disaster with existing resources; and

WHEREAS, such disasters may also give rise to unusual technical needs that the Town of Grant-Valkaria may be unable to meet with existing resources, but that other local governments may be able to provide; and,

WHEREAS, the Emergency Management Act gives the local governments of the State the authority to make agreements for mutual assistance in emergencies, and through such agreements to ensure the timely reimbursement of costs incurred by the local governments which render such assistance; and,

WHEREAS, the Department of Community Affairs, under its Division of Emergency Management, has authority to coordinate assistance between local governments during emergencies and to concentrate available resources where needed; and

WHEREAS, the Interim Council of the Town of Grant-Valkaria, acting as the interim town government as provided by the Town Charter, agrees that it is prudent to obtain the benefits of the mutual assistance agreements and coordination by the Department of Community Affairs for the Town;

NOW, THEREFORE BE IT RESOLVED BY THE INTERIM TOWN COUNCIL OF THE TOWN OF GRANT-VALKARIA, BREVARD COUNTY, FLORIDA, as follows:

SECTION 1. ADOPTION OF AGREEMENT FOR MUTUAL AID WITH THE STATE OF FLORIDA. The Interim Town Council of the Town of Grant-Valkaria does hereby adopt the Statewide Mutual Aid Agreement which is an agreement between the Department of Community Affairs, State of Florida, and the Town of Grant-Valkaria as a participating party.

SECTION 2. CONFLICTS. All resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict with this resolution.

SECTION 3. EFFECTIVE DATE. This Resolution shall take effect immediately upon passage.
